

Problem: Time inconsistency

Stability

Rule *(to influence expectations)*

- Price stability

promise not to inflate in the future

Independent central bank

- Fiscal debt sustainability

promise to spend in recessions (now)
but consolidate (later)

Independent fiscal council

- Financial stability

promise only to provide liquidity
but not to bail-out (redistribute to)
insolvent institutions
